In exchange for CCORS's accepting my entry form, I voluntarily agree to assume all risks incident to the sport of bike racing, I fully understand and comprehend the dangers of bike racing created by the sharp edges of rocks, tree parts, etc. found in the trails when racing in such event. With full knowledge, comprehension and understanding of these dangers, I voluntarily accept and assume all risks involved in the spirit of competitive bike racing. I will further read and comply with all the CCORS rules and regulations noting existing weather conditions, and do agree that I voluntarily assume all risks arising from conditions related to use of the event site by myself and others. In consideration of your acceptance of my entry, I intend to be legally bound, hereby, for myself, my heirs, executors and administrators, hold harmless and release and forever discharge the CCORS officials and volunteers, Club Presidents and members, the State of North Carolina, all COASTAL CAROLINA OFF-ROAD SERIES National Sponsors and local sponsors, their members, agents and any officials connected with this competition, from all liabilities for injuries and damages whatsoever, arising from my presence or participation in the above described event and do hereby grant the sponsors such release as described herein.
